

School Annual Education Report (AER) Cover Letter 2020-2021 School Year

Dear Parents and Community Members:

We are pleased to present you with the Annual Education Report (AER), which provides key information on the 2021-22 educational progress for Pontiac Academy for Excellence. The AER addresses the complex reporting information required by federal and state laws. The school's report contains information about student assessment, accountability, and teacher quality. For the 2021-22 school year, schools were identified based on previous years' performance using definitions and labels as required in the Every Student Succeeds Act (ESSA). A Targeted Support and Improvement (TSI) school is one that had at least one underperforming student subgroup in 2018-19. An Additional Targeted Support (ATS) school is one that had a student subgroup performing at the same level as the lowest 5% of all schools in the state in 2017-18. A Comprehensive Support and Improvement (CSI) school is one whose performance was in the lowest 5% of all schools in the state or had a graduation rate at or below 67% in 2016-17. Some schools are not identified with any of these labels. In these cases, no label is given.

Our school was not given one of these labels.

Pontiac Academy for Excellence strives to provide quality education with a focus on academic achievement, academic growth and meeting the needs of each student. The data from state testing (M-STEP) and the district assessments (NWEA) are reviewed after each testing cycle. The Academy is scoring below the state average in English language arts and mathematics. However, the Academy has a focus on the core content areas with intentional instruction in order to raise student scores. The key challenges faced by the Academy last year were:

- teacher retention
- leadership changes and staff turnover
- student enrollment challenges
- challenges due to the Covid-19 pandemic, including virtual learning

 addressing the academic needs of students performing below grade level in English language arts and mathematics

To address these challenges PAE is doing the following:

- Implementation of a MTSS (Multi-Tiered System of Support) with a focus on Tier I instruction
- Positive Behavior Support initiatives (PBIS)
- Monthly climate culture meetings with Home School Liaisons
- Monthly grade level data team meetings with Principal
- Using student academic data to individualize instruction
- Formative assessments and quarterly benchmark assessments,
- Increase professional development (PD) support for all instructional staff
- Implementation of a structured PLC cycle that provides opportunities for teacher collaboration between grade levels and/or grade bands along with intervention and special education departments

State law requires that we also report the additional information below.

Process for assigning pupils to the school

Pontiac Academy for Excellence offers open enrollment for all students in grades K-12. Parents provide application information, previous report cards and any behavioral documents. All information is reviewed prior to enrollment. There is no screen out based on disability, race, religion, gender, test scores, etc. When enrollment exceeds school enrollment capacity, a lottery process will be utilized for any additional open seats. Parents are notified with a phone call when students are accepted for enrollment.

The status of the 3-5 year School Improvement Plan

Pontiac Academy for Excellence School Improvement Plan (SIP) is a living, working document, developed by the administration and staff members. The SIP is designed to provide long term direction to address instruction, assessment, school culture, and professional development. The SIP specifically addresses instructional needs in the core content areas of reading, writing and mathematics, in addition to climate/culture, PBIS and ESL. Access to Core Curriculum

Pontiac Academy for Excellence core curriculum is based on the Michigan Academic Standards. The Academy works closely with our authorizer, Saginaw Valley State University, to ensure the curriculum is aligned and updated to optimize teaching and learning. The Academy curriculum development is overseen by our leadership team. In order to facilitate curriculum delivery, teachers create weekly lesson plans, meet in weekly grade-level team meetings, conduct pre/post assessments and attend monthly data meetings. 


Local Aggregate Student Achievement Results




















Parent-Teacher Conferences
